General Public Comment – Not earlier than 11:15 AM

General Public Comment was called.

Jordan Fein, Lead Research Analyst at UNITE HERE Local 11, addressed the Board regarding labor disputes with SFERS Investment Manager Blackstone Group and urged the Board not to re-invest in Blackstone until contract disputes are resolved.

Graciela Navarro, worked for 14 years as a Housekeeper at the Sheraton which is owned by Blackstone. Ms. Navarro spoke about low wages and the need for affordable health care.

Rosalba Sanchez, housekeeper at Sheraton, spoke about her struggles with not being able to retire due to rising costs and urged Blackstone to settle a fair contract for the workers.

Anand Singh, President, Local 2, spoke about basic necessities for workers and that many workers are living in poverty and asked the fund not to re-invest with Blackstone until contract disputes are resolved.

Laura Perez, an organizer with Local 11 based in Arizona, spoke about workers at Blackstone hotels asking for living wages, affordable healthcare and a safe and human workload and requested an item be added to the September meeting to not re-invest with Blackstone until contract disputes are resolved.
