Under its delegated authority, SFERS invested \$10 million in Fortress Real Estate Opportunities Fund IV (A) LP, which closed on March 11, 2024. This investment is classified as a Real Estate investment within the Real Assets portfolio and is SFERS' sixth investment with Fortress Investment Group.

Fortress Japan Opportunity Fund V (Dollar A) L.P.

Under its delegated authority, SFERS invested \$57.5 million in Fortress Japan Opportunity Fund V (Dollar A) L.P., which closed on March 11, 2024. This investment is classified as a Real Estate investment within the Real Assets portfolio and is SFERS' seventh investment with Fortress Investment Group.

Sustainable Asset Fund IV, LP

Under its delegated authority, SFERS committed \$80 million to Sustainable Asset Fund IV LP, of which \$57.55 million closed on December 27, 2023. The remaining \$22,450,000 closed on March 12, 2024. The investment is classified as an Infrastructure investment within the Real Assets portfolio and is SFERS' fourth investment with Vision Ridge Partners.

Mr. Ungerman reported that they conducted a search for a Diversified Real Asset ("DRA") Fund to potentially replace the current REIT fund within the SFDCP to offer participants a more diversified inflation hedging strategy.

Callan completed the search and interviewed three finalists:

- 1. Cohen & Steers Real Assets Fund (MF ticker: RAPIX)
- 2. PIMCO Inflation Response Multi-Asset Fund (MF ticker: PIRMX)
- 3. State Street Real Assets Strategy CIT (Class C)

Callan recommended that the Board replace the SFDCP Real Estate Fund managed by Principal with a SFDCP Diversified Real Asset Fund managed by State Street.

Greg Ungerman, Callan, presented a review of the Plan's investment performance for the second half of 2023.

Key Highlights:

- The Deferred Compensation Plan was valued at \$5 billion on December 31, 2023.
- The management of the custom target date funds changed as of June 30th from Russell Investments to T. Rowe Price.
- Watch List Update There are two funds of note based on the three- and five-year time periods summarized below:
 - 1. The SFDCP Large Cap Growth fund ranks in the 3rd quartile and behind the growth index for the 3- and 5-year periods. The fund is comprised of T. Rowe Price and the Vanguard Growth Index fund. The T. Rowe growth fund fell short of the peer group given the significant sell off in their tech holdings during 2022. T. Rowe has performed very well in 2023. The SFDCP Large Cap Growth fund was up 46.7% for the year and ranks in the 20th percentile of the peer group.
 - 2. The SFDCP International Equity fund ranks in the third quartile for the three- and fiveyear time periods given the allocations to Emerging Markets. EM has fallen short of Developed Markets recently. The fund is ahead of the benchmark for the five-year but behind over three years.
