6. 041024-06 Action Item Surplus Transfer of \$7mm savings to Professional Services to be used for relocation-related expenses

Alison Romano, CEO & CIO, reported that SFERS has cost savings in excess of \$7 million from its fiscal year 2022-23 budget and seeks to use \$7 million in cost savings to meet its operational need to pay for its relocation expenses, including relocation-related professional services. The SFERS Executive Team requested Board approval to use up to \$7 million to pay for relocation expenses and requested that the Board direct the Chief Executive Officer and Chief Investment Officer to seek Board of Supervisors approval to fund the relocation expenses through the \$7 million surplus transfer of carryover funds from the department's 2022-23 budget.

## 9. 041024-09 Action Item Adoption of New Strategic Asset Allocation

Documents provided to the Retirement Board prior to the current meeting: Staff Memorandum, Wilshire's presentation entitled "Asset and Liability Study (ALS): Recommendation and Implementation - Supporting the 2023-2024 SFERS ALS."

Tom Toth, Chris Tessman and Ali Kazemi, Wilshire, presented and oral and written report on this item.

Staff and Wilshire recommended adopting Portfolio D as the new Strategic Asset Allocation (SAA). Portfolio D reduces risk by allocating 8% less to growth assets: reducing Public Equity allocation from 37% to 32% and Private Equity from 23% to 20% and improving liquidity by introducing 1% allocation to Cash and increasing Public Credit allocation by 7% from 5% to 12%.

The presentation summarized the framework used to make the recommendation and how the various portfolios compare on SAA objectives, qualitative considerations related to implementation, and quantitative measures of return, risk and liquidity.

The Board engaged in a question and answer session.

John Furlan commented that whatever the Board votes on the staff will do well and that the key thing is going to be the implementation.
